G. Bringmann: We should question somethings. LIRR says they close early because of vagrancy and vandalism. LIRR can reach out to local municipalities to keep a closer eye on them if it meant keeping them open longer.

M. Epstein: LIRR says it's the towns that ask them to close the waiting rooms earlier.

18:57 G. Bringmann: previously there was no follow up of issues and record them. I.e. trains that mis-platform. Sometimes the crews haven't caught it and the doors have opened to no platforms. We asked the LIRR if they record/track them or give penalties. 21:33 M. Epstein: Follow up on the camera letter
L. Daglian: My concern is they would say it's a homeland security issue and not release that information.
M. Epstein: the guestions are listed in the letter

  05:00 Went from train 'late 6 min' to train 'ETA.' Still need to update the GPS tracking to be more accurate.
  M. Epstein: I'm more concerned about the information on the app. But they are all connected.
  G. Bringmann: Improved verbal announcements on where to board train. They should have email blast about schedules on holidays.
  - 11:17 M. Epstein: LIRRCC posters in LIRR stations. Follow up on LIRRCC posters in waiting rooms. Coloring should not blend in with LIRR
  - 12:20 L. Rubenstein: Complaints about music on platforms at new stations.
  - 16:08 M. Epstein: We want to tour M9s before they go into service. Ask LIRR for the tour
  - 18:40 L. Rubenstein: We would like to know when the focus groups are, what are the questions are, the feedback, actions taken.
  - 20:33 M. Epstein: Maintenance of station schedules. Ask for signs to be posted of dates when last inspected/ cleaned. Should be online as well
    - Getting a generic council cards
    - Reschedule Meet the Council events around November at Penn and Atlantic.
    - Virtual town hall with the president (ask about how to do that)
    - Meet the station managers
    - List of 5 things you didn't know about the LIRR (positive/informational)
